ORAL ARGUMENTS REQUESTED

Motion is respectfully made to this court for the issuance of a Writ of Execution against defendants in favor of Plaintiff in the amount of \$7333.

By withholding official action mandated by Article V of the Constitution, namely calling a convention, defendants have committed numerous illegal acts.¹ Such refusal has resulted in the collection of income tax against the Plaintiff where, had defendants obeyed the Constitution, such income tax would not exist.² Under these circumstances, defendants have committed extortion against Plaintiff.

1 Plaintiff in other motions has requested referral to the United States Attorney General
2 regarding the criminal actions of extortion by the defendants.³ He now seeks civil reparation
3 from the defendants under the terms of 26 U.S.C. 7214(a)(9) which states (in part):

4 “The court also shall render judgment against the said officer or employee
5 for the amount of damage sustained in favor the party injured, to be collected by
6 execution.”

7 As vetoing the Constitution can in no way be considered the “official duties” of the de-
8 fendants, it is clear that the terms of 28 U.S.C. 2006 can not be applied by the court. The statute
9 states:

10 “Execution shall not issue against a collector or other revenue officer on a
11 final judgment in any proceeding against him for any of his acts, or for the recov-
12 ery of any money exacted by or paid to him and subsequently paid into the Treas-
13 ury, in performing his official duties, if the court certifies that: (1) probable cause
14 existed; or (2) the officer acted under the directions of the Secretary of the Treas-
15 ury or other proper Government officer. When such certificate has been issued,
16 the amount of the judgment shall be paid out of the proper appropriation by the
17 Treasury.”

18 As admitted by the IRS,⁴ the Secretary of the Treasury is under the direction of the de-
19 fendants. Thus 28 U.S.C. 2006(2) cannot be applied favorably to the defendants as they were not
20 “act[ing] under the direction of the Secretary of Treasury or other proper Government officer.”
21 As noted in other motions and Plaintiff’s brief,⁵ defendants vetoing a clause of the Constitution is
22 not part of their official duties as such act violates federal criminal laws. Therefore there is no
23 basis whatsoever to support probable cause exception of 28 U.S.C. 2006(1) as such probable
24 cause must be ultimately based on defendants “performing [their] official duties” which they
25 have not. Therefore there is no basis for the court to issue a certificate which assigns appropria-
tion to the Treasury.

26 The defendants are therefore liable for the entire amount to reparation owed the Plaintiff
27 and such debt may not be transferred to the United States. Plaintiff therefore moves payment of

1 the reparation be equally divided among all defendants who shall each pay an equal amount to
2 the Plaintiff. Plaintiff does not seek any interest or other civil penalties in this reparation. Pro-
3 posed order attached.
